# Highlights, February 5 Annual Meeting, Board of Directors Meeting By Carol Heckert; Reviewed by John Fitzgibbon

#### Board of Directors election:

Maureen Emmons and John Fitzgibbon were re-elected to 2-year terms. Cathy Daignault was elected to finish out the last year of Larry Dobias' term. The rollover of \$33,000 from 2019 was approved. These actions occurred February 5, 2020, during Rivendell's annual meeting and a subsequent Board of Directors' meeting.

### Pine View School presentation:

The principal of Pine View School and the project manager for the new school building gave a presentation about their plans for the building. The new building will be 3 stories high and will replace the pods that are there now. It will be 10 feet from the Pine View Path at its closest point. A construction road will run parallel to the Pine View Path from Old Venice Road. All trees removed to make the road will be replaced with native trees once the building is completed. A question was asked about the trees marked with white ribbons. This was done as part of a survey; they will not all be removed. Construction will begin this summer and continue until December 2021. All work will take place on weekdays.

#### Police presentation:

Deputy Karen Hicks spoke about preventing crime in Rivendell.

#### Ponds and Preserves presentation:

Sue Remy made a presentation about the proposed Low Maintenance Zones. The proposal is to establish a low maintenance zone (LMZ) behind all houses that back onto our storm water ponds. The LMZs will extend 3 feet from the pond, with grass growing 8 – 12 inches high. The reason for this proposal is to prevent erosion caused by irrigation and rain runoff, wind driven waves, and the weight of heavy mowers. The community is already maintaining a low maintenance zone on all banks of ponds that are not behind houses. The plan calls for West Bay to maintain the LMZs behind houses as well. There are sufficient funds in the 2020 budget to cover the cost. It was noted that the area up to approximately 10 feet from the ponds is common area. Although homeowners have been required to maintain this area, the community owns it.

In addition to the LMZs, the community plans to place aquatic plants in the water next to the shorelines. This has been tried in Egret and Bobcat Ponds with mixed success. The hope is that the LMZs will prevent much runoff that creates algae in the ponds, and Aquatic Systems will not need to spray the ponds with the quantity of chemicals that kill aquatic plants.

Rivendell is responsible by law for maintaining our storm water system. Several nearby communities (Waterford, Stoneybrook in Venice) have already had to remediate the functioning of their systems, which can cost several million dollars. Rivendell's goal is to prevent this from happening in our community by taking action to prevent erosion now. The proposed action could save us a great deal of money in the future.

Until the current proposal is approved and adopted by the Board of Directors, homeowners living on ponds were asked to voluntarily maintain 3 foot LMZs behind their houses and to decrease their use of fertilizer. The Board will evaluate the potential financial costs and responsibility for additional LMZ maintenance at the March and April Board meetings, with an official vote of the Board to be taken soon after.



# We're Getting Our Ducks in a Row -Ducks (& Wildlife) Will Thank Us By the Rivendell Ponds and Preserves Committee

As you have been hearing, the Rivendell Board, along with the Ponds and Preserves Committee, has already been active this year to help control erosion damage on our pond shorelines. Erosion is visible on most Rivendell ponds, as evidenced in the slideshow at

the February HOA Annual Meeting. A significant majority of residents were positive and supportive of the proposed program and actions.

Many similar communities are dealing with these erosion issues as well. Like a sitting duck, neglected erosion damage continues to get worse – until a significant remediation is required - at great HOA expense. Rivendell is taking steps now to control receding shorelines and erosion damage to avoid expensive repairs later. We cannot duck out of responsible pond management. Erosion is not only unsightly, it disrupts the functional flow of our deeded stormwater system, reduces water filtration, and degrades natural habitats.

We must not duck this issue! Healthy ponds keep property values strong. Our community must take action now to address erosion damage. To be effective yet keep costs lower, Rivendell has adopted a "Natural Shorelines" Program. Much like a duck takes to water, this straightforward plan helps provide stability to the pond bank to prevent erosion, reduces fertilizer runoff into the pond, and creates a stronger balance with nature.

#### **Healthy Rivendell "Natural Shorelines" Action Steps**

 The Board has established a community-standard 3-foot Low-Maintenance Zone (LMZ) policy for all shorelines currently mowed by the community. The HOA landscape

contractor will no longer mow to the edge of the ponds. Grass in the LMZ will be maintained to a height of 8-12 inches. (Note that all pond shorelines and LMZs are on community-owned common ground.)

- The Board encourages all homeowners adjacent to a pond to install a 3-foot LMZ around their pond, in accordance with the community-standard LMZ. The Board is seriously considering implementing a policy of mandatory LMZs for all homes adjacent to ponds.
- Aquatic plantings have also been shown to filter chemical nutrients flowing into the ponds. Excess nutrients can worsen algal growth. Native plants have deeper roots that hold the soil on the bank, reduce wave action, and absorb water runoff. More aquatic plantings will be installed beginning this year and phased in as budgets allow.

Your actions make a difference! Getting our ducks in a row to fight erosion now helps keep the ducks and wildlife enjoying our healthy ponds forever. Rivendell residents are lucky ducks!



# LMZs are Now the Community Standard for Managed Shorelines Along Ponds. Your Actions Make a Difference.

The Rivendell Board has agreed to install Low-Maintenance Zones (LMZs) on community-mowed pond shorelines along roads to reduce erosion and nutrient runoff.

- These LMZs will be maintained to the community standard of a 3-foot width and trimmed to 8-12" on a regular schedule.
- Shorelines bordering preserves won't be mowed and will be allowed to grow naturally.
- While the Board researches extending this policy to all ponds community-wide, we strongly encourage homeowners living adjacent to a pond to install a voluntary LMZ (no mowing within 3 feet of the bank). Please prevent grass clippings from going into the pond and avoid cutting aquatic plants.

# Construction Update From Sarasota County

US 41 from Blackburn Point Road to Preymore Street: Construction project: Crews are resurfacing the roadway, replacing the US 41 northbound bridge over North Creek, improving drainage, constructing sidewalk and installing new highway lighting. Expect nighttime/overnight northbound lane closures from 6 p.m. to 6 a.m. And nighttime/overnight southbound lane closures from 6:30 p.m. to 9:30 a.m. A traffic shift is tentatively scheduled to be implemented on **Friday, February 21.** Northbound traffic will shift to one of the southbound lanes, reducing traffic to one lane each direction. Once implemented, the traffic shift is expected to be in place for approximately eight months while crews reconstruct the northbound bridge over North Creek. Bergeron Land Development, Inc. is the contractor. Expected completion is spring 2021.

# Pine View School Expansion to Begin This Spring By Kristine Nickel

A \$28M expansion of Pine View School for the Gifted will begin in the spring of 2020 according to Paul Pitcher, the project manager for the construction of the three-story, 80,000 sq. ft. building. "We will be starting mid-to-late spring on the (construction) road with the construction to start the first week in June," said Pitcher during the Annual Homeowners Association meeting February 5.

The road is needed to obtain access to the building site, which is located on the southeast corner of the Pine View School property, adjacent to Rivendell. Pitcher was quick to assure the homeowners gathered at the standing-room-only meeting that the road would, "hug as close as we can to our property line." As a point of reference, the closest point between the school's property line and the Rivendell path is 10 feet.

Residents who regularly use the path have been curious about the markings on various trees along the path. Pitcher clarified that issue early in his presentation saying that the markings were used as part of the survey process. Some trees, "old nasty palmettos and pine trees" will be removed as part of the construction, and upon project completion the

plan calls for the planting of native species to "recreate the buffer," said Pitcher.

Other areas of concern voiced by residents included noise and potential traffic congestion on Old Venice Rd. According to Pitcher the construction crews "will try to stay away from bringing trucks in during student pick-up times." He also assured the crowd that the project would maintain county standards for noise and dust abatement. Construction hours are expected to be between the hours of 7:30am and 3:30pm. Residents who encounter problems may get in touch with Lighthouse Management, the project's point of contact.

The presentation began with an introduction of the Pine View School Principal, Steven Covert, a former Rivendell resident. During brief remarks, Covert stressed that the school's intention is to always be a good neighbor and to partner during the process of building the new 3-story classroom building. It will replace 46 portable mobile learning centers currently used by the grade 2-12 school. Pine View School is ranked as the top public school in Florida and among the top 15 schools in the U.S. making it a "magnet for folks to come to Florida," said Covert.



# Spotlight on Doreen and Joe Sefack By Kristine Nickel

Not many people purchase a house sight unseen but for Doreen and Joe Sefack, their 2003 selection of 1056 Scherer Way was a slam dunk. "We selected the house online," admits Joe. Doreen quickly qualifies the story by adding that there really were several influencing factors. "We knew we wanted the West Coast of Florida," she adds. "And my doctor in New Jersey highly recommended Sarasota because of the reputation of the hospital here." The final factor was that a friend from their church in N.J. lived on Mallard Marsh and raved about Rivendell. "We called her agent, looked at floor plans, put down a deposit and came down and closed the deal," recounts Joe.

Neighbors and people who worked with Joe during the many years he served on the Rivendell Board of Directors as well as various committees would scarcely call Joe an impulsive person. "It may seem that I make decisions quickly, but people don't always see all of the research that goes into decision making," he says. Doreen concurs, saying they research and talk about everything extensively. "It's worked in our relationship for 58 years."

Doreen and Joe will be taking a new turn in that relationship when they move to Bay Village later this spring. Health issues are a driving force, but they're taking the move with their usual aplomb. "Downsizing has been interesting," says Doreen. Joe points to the generous help their neighbors have offered in smoothing out the rough patches in this journey by pitching in with Goodwill runs and clearing out duty. "One of

our neighbors even helped us find a new home for our dog," exclaims Doreen. Indeed, Maggie May. the Wheaton Terrier. is already ensconced in another loving home, easing the Sefacks' worry about their beloved companion.

The help Joe and Doreen have received is emblematic of their feelings about Rivendell. "I have such admiration for people who volunteer and give back to this community," says Joe. "Year after year people do a yeoman's job and they rarely get acknowledged. But without the dogged determination, time and effort of people here, it wouldn't be the community it is. Rivendell's gone from being a nice place to live to a showplace."

And although Joe wouldn't give himself much credit for being part of the transformation he cites, his many years of service have been much appreciated. For this former Chevrolet dealer from New Jersey, volunteering on the HOA was just the right fit for his retirement. "In 2006-2007 I wasn't really involved in anything else," he recalls. When a board position became available mid-term he called then president Ellie Hartle to volunteer. "I served out that term and then through unfortunate circumstances I became president of the Board. It was learning under fire. But I really enjoyed it and I especially loved working with the Board and all the homeowners. In fact, through 2019 I never missed a meeting."

Now that's what I call not just volunteering but something close to devotion. Rivendell's loss will be Bay Village's gain.

# Places to Go: Florida Southern College Campus is all Wright Submitted by Linda Pearlstein; excerpts from Andrea Sachs. The Washington Post

Florida Southern College in Lakeland is famous for its Frank Lloyd Wright designed buildings. FSC's "Child of the Sun" campus is famed as the world's only Wright-designed college and the largest single-site collection of his works.

Founded in Orlando in 1883, the private United Methodist-affiliated college relocated to a 100-acre orange grove on Lake Hollingsworth in 1922, when traditional red brick was stylish.

In 1938, FSC president Ludd M. Spivey sent Wright a letter requesting a meeting to build "a great education temple in Florida." Spivey hoped that the architect's fame could boost interest and applications. The pair stuck together for nearly 20 years, from the first construction in 1941 (the Annie Pfeiffer Chapel), to Wright's last: the Polk County Science Building, dedicated in 1958, a year after Spivey's retirement and a year before Wright's death.

The institution has earned distinctions for its academic standards but, more impressive, it once received a shout-out from the *Princeton Review* as the most beautiful campus in the United States (first place in 2011 and 2012). The school also joined the National Historic Landmarks club, which includes such sites as the Hoover Dam, the Empire State Building and

Taliesin West, Wright's former home and school in Arizona.

Wright fanciers can tour the campus year-round, either by grabbing a map from the parking lot and going it alone or taking a guided tour. You may receive special allowances with a guide, such as the thrill of standing beneath the theater's acoustically crisp cupola dome and performing your best Olivier-as-Hamlet impression.

"Wright said that he would design buildings that would look like they were coming out of the earth, like a child in the sun," a guide said of the architect's vision. The name stuck.

The tour starts at the Child of the Sun visitor center, which is housed in the former library and was completed in 1946. On the guided tour, the docent may include a brief overview about Wright's life, including the personal (such as his three wives and three mistresses) and the professional (such as the Prairie-style houses in the Midwest, the Imperial Hotel in Tokyo, and Taliesin East in Wisconsin. Not to mention the UFO-shaped room in which you may be sitting, with its 18-foot-high pit skylight and no interior walls).

#### Rivendell Home values - Short term trend


