# NEW ADDITIONAL VOTING INSTRUCTIONS FOR OUR ANNUAL MEMBERSHIP MEETING 2/6/21

The Board would like to request that the membership **check the proxy box** in order to allow our Treasurer, Cathy Daignault, to vote for you to allow us to apply the excess funds for 2020 to the following year's assessments as allowed under IRS Revenue Ruling 70-604.

Revenue Ruling 70-604 is a tax ruling only. The purpose of this ruling is to allow a homeowner's association to **avoid taxation** on any excess member income (as defined in the Internal Revenue Code) that may inadvertently arise in a given tax year. The ruling applies to any excess member income. The ruling allows two options only; (1) refund the excess member income to the members or (2) apply the excess to the following year's assessments.

The Board of Directors has determined that it is impractical to attempt to refund the excess member income because of the administrative issues involved and

the fact that the excess member income may be need as working capital to pay for continuing Association operating expenses. Therefore, the Board of Directors request that you approve an election under Revenue Ruling 70-604 to apply any excess member income to the following year's assessments. This does not mean that the assessments for next year will be reduced, as the budget has already been prepared and approved. Since expenses typically rise year-to-year it is probable that any excess member income will be absorbed by an increase in expenditures. This is especially true this year since we were unable to get many of our normal maintenance procedures completed this past year due to Covid and we will need the funds to get these projects completed this year.

If you have already voted by mail this does not apply to you. If you have not yet voted by mail we would appreciate it if you could check the proxy box and allow Cathy Daignault to approve this election on your behalf.

(RESIDENTS WHO HAVE OPTED IN TO ELECTRONIC VOTING) If you have already voted through HOAst, or if you haven't yet submitted your vote, we would like to request that you go in to the proxy page on HOAst and check the box allowing Cathy Daignault to approve this election on your behalf.
